

## Terms and Conditions of FOPSA's Christmas Trees and Wreaths Sale Lottery

1. One prize of a Nordmann Fir Christmas Tree or DIY Christmas Wreath Kit is available.
2. Promotion is open to the residents of the United Kingdom only. Entrants must be over 18 years of age.
3. Employees of FOPSA (the 'Promoter') and related companies are excluded from this competition.
4. The Promoter reserves the right to verify the eligibility of entrants.
5. The purchase of a Christmas Tree or Wreath Kit is required to enter the lottery.
6. All personal details will be handled in accordance with the Promoter's privacy statement.
7. One Prize Draw entrant will be selected by FOPSA. The closing time and date for entry is 10:00pm on Saturday 26 November. Any submitted entries received after this time will not be eligible.
8. The Prize Draw winner will be drawn at random and will be notified within 72 hours. The judge's decision is final. Any correspondence will only be entered into at the discretion of the Promoter.
9. By entering the Promotion, entrants agree to take part in any publicity related to the Promotion, including photography and publication of their names.
10. The prize will be awarded in the form of a refund to the original payment method.
11. The prize cannot be altered to a value different from that of the original purchase.
12. The Promoter will not be liable if the Prize cannot be taken by a winner for any reason beyond the control of the Promoter. Return of prize notification as undeliverable or failure to respond to a prize notification within a reasonable time will result in disqualification and an alternate winner may be selected at the Promoter's discretion. In the event that a winner declines his or her prize the Promoter may elect, at its own discretion, to select an alternative winner.
