#### **Summary of Discussion:**

- Position of Chair Person for FOSGS is still vacant. Discussed advertising the role. **EC** to create poster to include brief description of the role.
- Updated constitution has been submitted and is awaiting confirmation from the Charities Commission. Copy of Constitution to be added to FOSGS Facebook and website, and emailed to the Headteacher's by **EC.** Following confirmation, **EC** to look into option to add Gift Aid.
- EC has invested £1745 on new wristbands and the dates on the existing Adventure Island tickets have been extended. **EC** to advertise them, encourage online sales by including a hyperlink to the website, further information on height and band colour to be included on promotional material.
- Price change on tickets:
  - -Adventure Island £1 increase (to reflect price increase on gate) £17 blue, £13 green/red
  - Sealife £1 increase (to reflect price increase on gate) £7
  - Golf ticket prices to remain the same £4
  - Adventure Island Inside price reduction to £5 in a flash sale to shift tickets (usually £7)

- Junior Disco confirmed for 8th Feb. EC to purchase glow bracelets, rings and food for tuck shop. Request for volunteers.

- Mother's Day Afternoon Tea Infants 29th March EC to advertise for volunteers.
- Easter Egg Raffle Infants draw 4th April, Juniors 5th April. 25th March to start selling EC to create rota to sell tickets.
- Father's Day Gift Sale Juniors 7th June SL and EC to help with shopping.
- Fundraising Dinner Night to be on either 7th or 21st June. LG to look into Royal Tiger vs
  Maharaja and to get further details. Ticket sales at £18 pe head. LG to arrange advertising for
  after Easter Holidays.
- Junior Fun Event Previously discussed baking event proved too costly. Discussed the idea of having a visit from Living things (as used by the Infants), or Snakes Alive. MD to arrange meeting the School Council to discuss.
- Sponsored Walk for both schools. Dates to be decided, will likely need to be different dates for each school. MD and SI to look at viable dates.

- 100 Club has been formally closed; those who had still been paying in have been refunded, and other funds paid to FOSGS account.
